Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:  On April 24, 2017, the agency received a report regarding a one-year-old infant brought to the hospital with life threatening injuries. Medical professionals who examined the infant suspected head trauma due to the child's presenting symptoms, and child was transported to another hospital. Law enforcement was contacted and initiated a criminal investigation regarding the child's suspicious injuries. As a result of law enforcement's investigation, the infant's father was arrested and criminally charge with Physical Abuse of a Child, Repeated Acts of Causing Great Bodily Harm and Neglecting a Child (Consequence is Great Bodily Harm). A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty
Findings by agency, including maltreatment determination and material circumstances leading to incident:  The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the infant by father, and neglect to the infant by his father's significant other. Medical professionals determined the infant sustained multiplication including head injuries. The infant and his siblings were deemed unsafe, taken into Temporary Physical Custody, and placed in foster care with relatives. A Child in Need of Protection or Services Petition was filed and the case remained open provide ongoing case management services.

assessment was completed by the agency and the allegation of physical abuse was unsubstantiated. The case was closed upon completion of the initial assessment.
