### Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On May 21, 2017, the agency received a report regarding a 2-month-old infant pronounced deceased upon arrival at the hospital. Law Enforcement was contacted and initiated a criminal investigation into the infant's unexplained death. The Medical Examiner's Office noted no signs of maltreatment or trauma to the infant; toxicology results were negative. No criminal charges were filed and the case was closed.

### Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate physical abuse of the infant by the mother and father. The Medical Examiner's Office noted no signs of maltreatment or trauma to the infant. The infant's sibling was determined safe and the sibling remained in the home with his mother and father. The agency closed the case upon completion of the Initial Assessment and no service referrals were made.
