Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On August 1, 2017, the agency received a report regarding a 2-month-old infant pronounced deceased in his home. Law enforcement was contacted and initiated a criminal investigation into the infant's unexplained death. The Medical Examiner's Office noted no signs of maltreatment or trauma to the infant; toxicology results are pending. No criminal charges have been filed in this case, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate neglect of the infant by the mother. The Medical Examiner's Office noted no signs of maltreatment or trauma to the infant; toxicology results are pending. The infant's siblings were deemed unsafe, taken into Temporary Physical Custody, and placed in foster care. Child in Need of Protection or Services Petitions were filed for all six children. The case remained open to provide ongoing case management services.

At the time of the incident, the infant resided in his mother's home with his twin 2-month-old, 1-year-old, 3-year-old, 5-year-old, 7-year-old, and 8-year-old siblings. The infant did not have visitation with his father. A 14-year-old sibling was under the guardianship and custody of a relative and did not reside in the home at the time of the incident.

At the time of the incident, the family was open for assessment of the June 14, 2017 CPS Report. The last contact by the agency with the mother was a home visit on July 13, 2017.

On June 14, 2017 the agency screened-in a CPS Report alleging neglect to the infant and the infant's siblings by the mother. An assessment was completed by the agency and the allegation of neglect was unsubstantiated. The case was closed upon completion of the Initial Assessment.

On September 26, 2014 the agency screened-in a CPS report alleging physical abuse to the now 4-year-old sister by a non-caregiver. An assessment was completed by the agency and the allegation of physical abuse was substantiated. The case was closed upon completion of the Initial Assessment.

On June 14, 2017 the agency screened-in a CPS Report alleging neglect to the infant and the infant's siblings by the mother. An assessment was completed by the agency and the allegation of neglect was unsubstantiated. The case was closed upon completion of the Initial Assessment.

On September 26, 2014 the agency screened-in a CPS report alleging physical abuse to the now 4-year-old sister by a non-caregiver. An assessment was completed by the agency and the allegation of physical abuse was substantiated. The case was closed upon completion of the Initial Assessment.

On April 25, 2012 the agency screened-in a CPS Report alleging neglect to the infant's now 5-year-old sibling by the mother. An assessment was completed by the agency and the allegation of physical abuse was unsubstantiated. The case was closed upon completion of the Initial Assessment.

In 2008, the mother's parental rights to the now 13-year-old twins were terminated.

On June 20, 2006 the agency screened-in a CPS Report alleging neglect to infant's now 14-year-old, and now 13-year-old twin siblings. An assessment was completed by the agency and the allegation of neglect was substantiated. Child in Need of Protection or Services Petitions were filed and the children were placed in foster care. The case remained open to provide ongoing case management services.

On June 16, 2006 the agency screened-out a CPS Report.

On May 17, 2006 the agency screened-out a CPS Report.

On June 9, 2005 the agency screened-in a CPS Report alleging physical abuse to the infant's now 14-year-old sibling by the mother. An assessment was completed by the agency and the allegation of physical abuse was unsubstantiated. The case was closed upon completion of the Initial Assessment.

On June 7, 2005, the agency screened-in a CPS Report alleging physical abuse and neglect to the infant's now 14-year-old and now 13-year-old twin siblings by the mother. An assessment was completed by the agency and the allegations of physical abuse and neglect were unsubstantiated. The case was closed upon completion of the Initial Assessment.

On February 1, 2005 the agency screened-in a CPS Report alleging neglect to the infant's now 14-year-old and now 13-year-old twin siblings by the mother. The agency was unable to locate the family to complete the Initial Assessment.

On December 10, 2004 the agency screened-in a CPS Report alleging neglect and physical abuse to the infant's now 14-year-old sister and neglect to the now 13-year-old twins. An assessment was completed by the agency and the allegations of physical abuse and neglect were unsubstantiated. The case was opened to provide ongoing case management services.

On December 7, 2004 the agency screened-out a CPS Report.

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate neglect of the infant by the

The infant's siblings were deemed unsafe, taken into Temporary Physical Custody, and placed in foster care. Child in Need of Protection or Services Petitions were filed for all six children. The case remained open to provide ongoing case management services.
