Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On August 22, 2017, the agency received a report regarding a 1-month-old infant pronounced deceased at her daycare. Law enforcement was contacted and initiated a criminal investigation into the infant's unexplained death. The Medical Examiner's Office determined the injuries were non-accidental in nature. As a result of law enforcement's investigation, the daycare provider was arrested and criminally charged with 1st Degree Reckless Homicide. A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate physical abuse of the infant by an unknown maltreater and neglect of the infant by the daycare provider. Medical personnel determined the injuries were consistent with non-accidental trauma. The daycare provider was criminally charged and court ordered to have no contact with the infant's family or any child under the age of 16-years-old. The agency closed the case upon completion of the Initial Assessment and no service referrals were made.
