**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On November 9, 2017, the agency received a report regarding a 3-year-old child brought to the hospital with multiple injuries. Medical personnel determined that some of the injuries were non-accidental in nature. Law enforcement was contacted and initiated a criminal investigation. As a result of law enforcement's investigation, the mother was charged with Felony Neglecting a Child (Consequence is Bodily Harm). A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the child by an unknown maltreater and neglect of the child by his mother. The child was deemed unsafe, taken into Temporary Physical Custody, and placed in a relative foster home. A Child in Need of Protection or Services Petition was filed and the case remained open to provide ongoing case management services.

At the time of the incident, the agency was assessing the September 13, 2017 and November 6, 2017 CPS Reports. The last contact by the agency was a home visit with the child and his mother on October 24, 2017.

Additionally, the child's mother's boyfriend was open to the agency under a Child in Need of Protection of Services Petition for another child with a different mother. The last contact by the agency was face-to-face with the child of that case on September 27, 2017.

An assessment was completed by the agency and the allegation of neglect was unsubstantiated. The 2-year-old child was deemed unsafe and a Child in Need of Protection or Services Petition was filed. The case remained open to provide ongoing case management services.

The case remained open under the May 2, 2017 CPS Report resulting in a Child in Need of Protection or Services Petition.

On May 2, 2017, the agency screened-in a CPS Report alleging neglect to a now 2-year-old son of the child's mother's current boyfriend (no relation to the above child subject) by the boyfriend and that child's mother. An assessment was completed by the agency and the allegation of neglect was unsubstantiated. The 2-year-old child was deemed unsafe and a Child in Need of Protection or Services Petition was filed. an unknown maltreater and neglect of the child by his mother. The child was deemed unsafe, taken into Temporary Physical Custody, and placed in a relative foster home. A Child in Need of Protection or Services Petition was filed and the case remained open to provide ongoing case management services.
