On July 28, 2019, the agency received a report regarding a 2-year-old child brought to the hospital with injuries. Law enforcement was contacted and initiated a criminal investigation. Medical personnel determined that the child's condition to be consistent with neglect. As a result of law enforcement's investigation, the child's father was charged with Neglecting a Child (Consequence is Great Bodily Harm). A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect to the child by his father. The child's father was criminally charged and court ordered to have no contact with the child. The agency determined the child and his 6-year-old half-sister safe and they remained in their mother's care. A Petition for Protection or Services was filed and the case remained open to provide ongoing case management services.
