Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On September 4, 2019, the agency received a report regarding a 16-year-old child pronounced deceased at the hospital. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted that his condition was consistent with neglect. The official cause of the child's death is undetermined; test results are pending. As a result of law enforcement's investigation, the mother was arrested and criminally charged with Chronic Neglect of Child (Consequence is Great Bodily Harm). A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate neglect of the child by the mother. The Medical Examiner's Office noted his condition was consistent with neglect. The official cause of the child's death is undetermined; test results are pending. The child's siblings were deemed unsafe, taken into Temporary Physical Custody, and placed with their father. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.
