**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On January 10, 2021, the agency received a report regarding a 3-month-old infant brought to the hospital with multiple injuries on January 9, 2021. The infant was pronounced deceased on January 14, 2021. Medical professionals determined the injuries were non-accidental in nature. Law enforcement was contacted and initiated a criminal investigation. As a result of law enforcement's investigation, the infant's father was criminally charged with First Degree Reckless Homicide. A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the infant by the infant's father. Medical professionals determined the injuries were non-accidental in nature. The agency deemed the infant's half-siblings unsafe, and they were taken into Temporary Physical Custody and placed with a relative. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.

At the time of the incident, the agency was assessing an October 27, 2020 CPS Report for Alternative Response. The last contact by the agency was via email with the family on November 16, 2020, where the agency attempted to schedule face-to-face contact.
