**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On May 14, 2021, the agency received a report regarding a 4-month-old infant pronounced deceased in his home on May 12, 2021. Law enforcement was contacted and initiated a criminal investigation. Medical professionals noted no signs of trauma to the infant; the final autopsy and toxicology report are pending. No criminal charges have been filed in this case, and the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect to the infant by the infant's mother. Medical professionals noted no signs of trauma to the infant; the final autopsy and toxicology report are pending. The infant's sibling was deemed unsafe and remained in the home under a Protective Plan. A Petition for Protection or Services was filed, and the case remained open to provide ongoing case management services.
