Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On August 6, 2021 the agency received a report regarding a 3-month-old infant brought to the hospital with multiple injuries sustained on August 1, 2021. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were non-accidental in nature. As a result of law enforcement’s investigation, the child’s father was criminally charged with Child Abuse – Recklessly Cause Great Harm. A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect and physical abuse to the infant by the father. Medical professionals determined the injuries were non-accidental in nature. The agency deemed the infant unsafe and initiated a Protective Plan. Subsequently, the infant was taken into Temporary Physical Custody and placed in a licensed foster home. A Petition for Protection or Services was filed, and the case remained open to provide ongoing case management services.

At the time of the incident, the agency was assessing the June 23, 2021, CPS Report. The last contact by the agency was on July 15, 2021.

On June 23, 2021, the agency screened-in a CPS Report alleging neglect to the infant. The infant sustained injuries during the assessment period, and an additional report was made to the agency regarding these injuries on August 6, 2021. An assessment was completed by the agency, and the initial allegation of neglect was substantiated.

On April 3, 2021, the agency screened-in a CPS Report for Alternative Response alleging neglect to the infant’s now

8-year-old half-brother, as well as unborn child abuse to the then unborn infant. An assessment was completed by the agency, and it was determined that services were not needed. The case was closed upon completion of the Initial Assessment.
