On September 6, 2021, the agency received a report regarding a 6-year-old child brought to the hospital with serious injuries. The child was pronounced deceased at the hospital. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the death to be non-accidental. As a result of law enforcement's investigation, the mother was charged with Chronic Neglect of a Child and False Imprisonment. A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.
Findings by agency, including maltreatment determination and material circumstances leading to incident:
The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the child by an unknown maltreater and a preponderance of the evidence to substantiate maltreatment of neglect to the child by the mother. The Medical Examiner's Office determined the death to be non-accidental. The child's 10-year-old and 9-year-old siblings were deemed unsafe, taken into Temporary Physical Custody, and placed in a licensed Group Home. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.
