Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On October 6, 2022, the agency received a report regarding an 8-month-old infant found unresponsive in her home and later pronounced deceased. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's autopsy report is pending. No criminal charges have been filed in this case, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect to the infant by the mother and the father. The Medical Examiner's autopsy report is pending. The agency deemed the infant's half-siblings unsafe. The infant's 3-year-old and 1-year-old half-siblings were placed in a licensed foster home, and the infant's 10-year-old half-sibling remained in the care of his father. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.

On October 2, 2019, the agency screened in a CPS Report alleging physical abuse to the infant's now 3-year-old half-brother by his father. An assessment was completed by the agency, and the allegation of physical abuse was substantiated. The case

was closed upon completion of the Initial Assessment.

On November 15, 2012, the agency screened-out a CPS Report.
