On August 7, 2022, the agency received a report regarding a child who was unconscious and taken to the hospital. The child was later pronounced deceased on August 11, 2022. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma; the autopsy report is pending. No criminal charges have been filed in this case, and the investigation remains open.

### Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate neglect of the child by the mother and the father. The child's siblings were deemed unsafe, and a Protective Plan was put into place. Subsequently, the Protective Plan was terminated, and the child's siblings were taken into Temporary Physical Custody and placed in non-relative foster homes. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.
