Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On September 12, 2022, the agency received a report regarding a 5-year-old child with multiple injuries. Law enforcement was contacted and initiated a criminal investigation. Medical professional determined the injuries were non-accidental in nature. Medical professionals also determined some of the injuries were consistent with non-organic failure to thrive. No criminal charges have been filed in this case, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse of the child by an unknown maltreater and a preponderance of the evidence to substantiate maltreatment of neglect by the child's grandmother. The child was deemed unsafe, taken into Temporary Physical Custody, and placed in a non-relative foster home. The child's 16-year-old relative was deemed safe and remained in the home with the child's grandmother. A Petition for Protection or Services was filed for the child, and the case remained open to provide ongoing case management services.

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse of the child by an unknown maltreater and a preponderance of the evidence to substantiate maltreatment of neglect by the child’s grandmother. The child was deemed unsafe, taken into Temporary Physical Custody, and placed in a non-relative foster home. The child’s 16-year-old relative was deemed safe and remained in the home with the child’s grandmother. A Petition for Protection or Services was filed for the child, and the case remained open to provide ongoing case management services.
