**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On October 29, 2022, the agency received a report regarding a 1-year-old infant with multiple injuries brought to the hospital on October 28, 2022. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the infant sustained serious injuries. As a result of law enforcement's investigation, the mother's significant other was criminally charged with Child Abuse-Recklessly Cause Great Harm. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate neglect of the infant by the mother's significant other. Medical professionals determined the infant sustained serious injuries. The infant and the infant's sibling were deemed unsafe and taken into Temporary Physical Custody. The infant was placed with a relative, and the infant's sibling was placed in a licensed foster home of a family friend. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.

At the time of the incident, the infant resided with her mother, her 10-month-old sibling, and the mother's significant other. The infant's 3-year-old and 7-year-old half-siblings were in out-of-home care and residing in a licensed non-relative foster home. The infant's father had regular visitation with the infant.

At the time of the incident, the infant's 3-year-old and 7-year-old half-siblings were placed with a licensed non-relative foster home under Child in Need of Protection or Services orders related to the October 24, 2019 Services Report. The last contact by the agency was with the mother on October 27, 2022.

On August 3, 2022, the agency screened-in a CPS Report alleging neglect to the infant by her mother. An assessment was completed by the agency, and the allegation of neglect was unsubstantiated. The case was closed upon completion of the Initial Assessment.

On October 24, 2019, the agency screened-in a Services Report. The agency opened the case to provide ongoing case management services.

On June 17, 2019, the agency screened-in a CPS Report alleging neglect to the now 3-year-old and 7-year-old half-siblings by the mother. An assessment was completed by the agency, and the allegation of neglect was unsubstantiated. The case was closed upon completion of the Initial Assessment.

On April 18, 2017, the agency screened-out a CPS Report.

The agency collaborated with law enforcement and medical professionals to complete the assessment.
