Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On March 4, 2023, the agency received a report regarding an infant who allegedly died on January 27, 2023. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma to the infant. The official cause of the infant's death was undetermined; toxicology results were negative. As a result of law enforcement's investigation, the mother was criminally charged with Neglecting a Child (Consequence is Death). A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect of the infant by the mother. The Medical Examiner's Office noted no signs of trauma to the infant. The official cause of the infant's death was undetermined; toxicology results were negative. The agency deemed the infant's sibling unsafe and initiated a Protective Plan. Subsequently, the Protective Plan was terminated, and the infant's sibling was deemed safe with the adult siblings who resided in the home. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.
