**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On February 2, 2023, the agency received a report regarding a 5-month-old infant found unresponsive in the home. The infant was taken to the hospital where she was later pronounced deceased. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma; the autopsy report is pending. No criminal charges have been filed, and the case was closed.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the infant by the mother. The Medical Examiner's Office noted no signs of trauma; the autopsy report is pending. The agency deemed the infant's sibling safe, and the infant's sibling remained with the mother and father. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.
