Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On April 8, 2023, the agency received a report regarding a 4-month-old infant brought to the hospital with multiple injuries. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were consistent with non-accidental head trauma. As a result of law enforcement's investigation, the infant's father was criminally charged with Physical Abuse of a Child, Repeated Acts Causing Great Bodily Harm. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the infant by an unknown maltreater and insufficient evidence to substantiate maltreatment of physical abuse by the infant's father. Medical professionals determined the injuries were consistent with non-accidental head trauma. The agency deemed the infant and the infant's sibling and half-siblings in the mother's home unsafe and initiated a Protective Plan. Subsequently, the mother was assessed as protective, and the infant and infant's sibling and half-siblings in the mother's home remained with the mother. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made. The agency deemed the infant's half-siblings and the two unrelated children in the father's home unsafe and initiated a Protective Plan. Subsequently, the father's significant other was assessed as protective, and the infant's half-siblings and the two unrelated children in the father's home remained in the home. The infant's father was criminally charged, and court ordered to have no contact with the infant, the infant's 4-month-old sibling or the 7-year-old unrelated child. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.
