Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On May 23, 2023, the agency received a report regarding a 16-year-old child brought to the hospital with significant injuries alleged to have been sustained on or around May 21, 2023. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were consistent with non-accidental trauma. As a result of law enforcement's investigation, an unrelated adult living in the home was criminally charged with Attempted 1st-Degree Intentional Homicide, Mayhem, and 1st Degree Reckless Injury. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the child by the unrelated adult living in the home. Medical professionals determined the injuries were consistent with non-accidental trauma. The agency collaborated with the consulate of the country the mother was living in to contact the child's mother. Subsequently, the mother was assessed to be protective, and the child returned to her care. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.
