On June 21, 2023, the agency received a report regarding a 3-month-old infant pronounced deceased in her home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma to the infant; the autopsy report is pending. No criminal charges have been filed in this case, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner's Office noted no signs of trauma to the infant; the autopsy report is pending. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the infant by an unknown maltreater. The agency deemed the infant's siblings unsafe and initiated a Protective Plan. Subsequently, the Protective Plan was terminated as the mother and father were assessed as protective, and the infant's siblings remained with the mother and father. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.
