Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On November 29, 2023, the agency received a report regarding a 10-month-old infant pronounced deceased in her home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma to the infant; the official cause of the infant's death was undetermined. No criminal charges were filed, and the case was closed.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner's Office noted no signs of trauma to the infant; the official cause of the infant's death was undetermined. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the infant by the mother and an adult relative. The agency deemed the infant's sibling unsafe and initiated a Protective Plan. Subsequently the mother was assessed as protective, and the infant's sibling remained with the mother. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.

On June 23, 2022, another agency screened-in a CPS Report alleging neglect to the infant's now 3-year-old sibling and the infant's now 12-year-old relative, 11-year-old relative, 8-year-old relative and 6-year-old relative by the mother. An assessment was completed by the agency, and the allegation of neglect was unsubstantiated. The case was closed upon completion of the Initial Assessment.
