Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma to the infant; the official cause of the infant's death was undetermined. No criminal charges were filed, and the case was closed.
Findings by agency, including maltreatment determination and material circumstances leading to incident:  The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner's Office noted no signs of trauma to the infant; the official cause of the infant's death was undetermined. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the infant by the mother and an adult relative. The agency deemed the infant's sibling unsafe and initiated a Protective Plan. Subsequently the mother was assessed as protective, and the infant's sibling remained with the mother. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.
