On December 21, 2023, the agency received a report regarding a 14-year-old child brought to the hospital with serious injuries. Law Enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were non-accidental in nature. As a result of law enforcement's investigation, the child's uncle was charged with Operator Flee/Elude Officer (Great Harm), Knowingly Operate w/o Valid License (Great Bodily Harm), and Injury by Use/Vehicle (Controlled Substance). A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. Medical professionals determined the injuries were non-accidental in nature. The Initial Assessment completed by the agency found a preponderance of evidence to substantiate maltreatment of neglect to the child by the uncle. The agency determined the child safe with her grandmother, who is her legal guardian. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.
