**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On September 16, 2024, the agency received a report regarding a now 8-year-old child that was the subject of an egregious incident that was alleged to have occurred on or around January 13, 2021. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were consistent with non-accidental trauma. No criminal charges have been filed in this case, and the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. Medical professionals determined the injuries were consistent with non-accidental trauma. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect, physical abuse or sexual abuse of the child by the father. The child was deemed safe with relatives under court-ordered kinship care. The family's case remained open for voluntary case management services.

On August 10, 2020, another agency screened-in a CPS Report for alternative response alleging neglect to the child, her now 8-year-old sibling, her now 10-year-old sibling, and her now 14-year-old sibling. An assessment was completed by that agency with the determination of services not needed. The case was closed upon completion of the Initial Assessment.

On August 8, 2016, another agency screened in a services report. The agency was unable to contact the family.
