Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On February 1, 2024, the agency received a report regarding a 10-year-old child brought to the hospital with multiple injuries. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were non-accidental in nature. As a result of law enforcement’s investigation, the child’s father was criminally charged with Strangulation and Suffocation, Victim Intimidation and Child Abuse – Intentionally Cause Harm. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. Medical professionals determined the injuries were non-accidental in nature. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the child by the father. The child and his siblings were deemed unsafe, and a Protective Plan was implemented. Subsequently, the child and his siblings were taken into Temporary Physical Custody and placed with relatives. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management.
