On February 8, 2024, the agency received a report regarding a 3-year-old child brought to the hospital with multiple injuries. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were non-accidental in nature. No criminal charges have been filed in this case, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. Medical professionals determined the injuries were non-accidental in nature. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate neglect of the child by an unrelated caregiver and physical abuse of the child by an unknown maltreater. The agency determined the child safe, and he remained with his mother. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.
