On February 20, 2024, the agency received a report regarding an 8-year-old child and a 5-year-old child who had been pronounced deceased in their home on February 18, 2024. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were non-accidental in nature. No criminal charges have been filed in this case, and the investigation remains open.

The agency collaborated with law enforcement and medical professionals to complete the assessment. Medical professionals determined the injuries were non-accidental in nature. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate physical abuse of the children by their mother. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.
