Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:  On February 18, 2024, the agency received a report regarding a 4-year-old child brought to the hospital with a head injury who was subsequently pronounced deceased. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the child died as a result of a serious injury. As a result of law enforcement's investigation, the child's mother was charged with Neglecting a Child (Consequence is Death). A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.
Findings by agency, including maltreatment determination and material circumstances leading to incident:  The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner's Office determined the child died as a result of a serious injury. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect of the child by the mother. The agency determined the child's half-siblings unsafe and initiated a Protective Plan. Subsequently, the mother was assessed as protective, and the child's half-siblings remained with their mother. The family's case remained open for voluntary case management services.
