On March 18, 2024, the agency received a report regarding a child who sustained multiple injuries on March 16, 2024, and was hospitalized. (The agency responded immediately upon receipt of the report. The critical incident notification to DCF was delayed due to a technical issue and was received on May 22, 2024.) Medical professionals determined the child sustained serious injuries. As a result of law enforcement's investigation, the child's father was criminally charged with Injury by Intoxicated Use of a Vehicle, Injury/Use of Vehicle with PAC – Passenger Under 16, and Second Degree Recklessly Endangering Safety. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. Medical professionals determined the child sustained serious injuries. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect and physical abuse of the child by the father. The child remained in-home with the mother under a Safety Plan. A Petition for Protection or Services was filed, and the case remained open to provide ongoing case management services.
