**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On April 13, 2024, the agency received a report regarding a 1-month-old infant brought to the hospital with multiple injuries. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were non-accidental in nature. As a result of law enforcement's investigation, the infant's father was criminally charged with Child Abuse-Recklessly Cause Great Harm. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. Medical professionals determined the injuries were non-accidental in nature. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the infant by the infant's father and an unknown maltreater. The agency deemed the infant and the infant's sibling unsafe and initiated a Protective Plan. Subsequently, the infant and the infant's sibling were taken into Temporary Physical Custody and placed with a relative. The infant's father was court ordered to have no contact with the infant or the infant's sibling. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.
