Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On April 27, 2024, the agency received a report regarding a 1-month-old infant brought to the hospital with multiple injuries. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were non-accidental in nature. As a result of law enforcement's investigation, the infant's mother was charged with Neglecting a Child (Consequence is Bodily Harm) and Neglecting a Child (Consequence is Great Bodily Harm), and the infant's adult relative was charged with Neglecting a Child (Consequence is Great Bodily Harm). A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. Medical professionals determined the injuries were non-accidental in nature. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate neglect of the infant by the infant's mother and adult relative. The infant was deemed unsafe, taken into Temporary Physical Custody, and placed in a non-relative foster home. The 5-year-old and 2-year-old children of the adult relative were deemed unsafe, taken into Temporary Physical Custody, and placed with a relative. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.
