On May 13, 2024, the agency received a report regarding a 2-month-old infant brought to the hospital and pronounced deceased. The Medical Examiner's Office noted no signs of trauma to the infant. The cause of the infant's death was undetermined; toxicology results are pending. No criminal charges were filed, and the case was closed.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner's Office noted no signs of trauma to the infant. The cause of the infant's death was undetermined; toxicology results are pending. The Initial Assessment completed by the agency found insufficient evidence to substantiate maltreatment of physical abuse of the infant by an unknown maltreater. The agency closed the case upon completion of the Initial Assessment, and referrals were made to community services.
