Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On June 10, 2024, the agency received a report regarding a 1-month-old infant who was found unresponsive and later pronounced deceased in his home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office has not determined the cause of death; the autopsy is pending. No criminal charges have been filed in this case, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner's Office has not determined the cause of death; the autopsy is pending. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect of the infant by the mother and the grandmother. The Initial Assessment completed by the agency found insufficient evidence to substantiate maltreatment of physical abuse by the mother, the grandmother, or an unknown alleged maltreater. The agency deemed the infant's 2-year-old sibling unsafe, and the sibling remained in the care of a non-relative foster home. The case remained open to provide ongoing case management services.

At the time of the incident, the infant resided with his mother. The infant had regular visitation with his father. The infant's 2-year-old sibling resided with a non-relative foster family and was visiting the mother when the incident occurred.

At the time of the incident, the infant's 2-year-old sibling was under a Child in Need of Protection or Services order related to the May 23, 2023 CPS report. The last contact by the agency was a face-to-face visit with the infant, the mother, and the father on May 9, 2024.

On May 24, 2023, the agency screened-in a CPS Report alleging neglect to the infant's now 2-year-old sibling by the mother. An assessment was completed by the agency, and the allegation of neglect was substantiated. A Petition for Protection or Services was filed on June 1, 2023, and the case remains open to provide ongoing case management.

On May 24, 2023, the agency screened-in a CPS Report alleging neglect to the infant’s now 2-year-old sibling by the mother. An assessment was completed by the agency, and the allegation of neglect was substantiated. A Petition for Protection or Services was filed on June 1, 2023, and the case remains open to provide ongoing case management.

The following history is related to the infant’s grandmother:

On April 12, 2002, the agency screened-out a CPS Report.

Summary of any investigation involving the child, any member of the child’s family and alleged maltreater conducted under ch. 48 and any services provided to the child and child’s family since the date of the incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect to the infant by the mother and maternal grandmother. The Initial Assessment completed by the agency also found insufficient evidence to substantiate maltreatment of physical abuse by the mother, the grandmother, and an unknown alleged maltreater. Autopsy results are pending, and the official cause of the infant’s death is unknown; toxicology results were negative. The agency deemed the infant’s 2-year-old sibling unsafe, and the child remained in the care of a non-relative foster home. The case remained open to provide ongoing case management services.
