Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On June 16, 2024, the agency received a report regarding an egregious incident involving seven children ages 1 month, 1 year, 2 years, 4 years, 5 years (two children), and 8 years. Law enforcement was contacted and initiated a criminal investigation. Medical professionals noted no signs of trauma to the children. As a result of law enforcement's investigation, the children's father was criminally charged with Neglecting a Child and the mother of the youngest five children was charged with Neglecting a Child. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. Medical professionals noted no signs of trauma to the children. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate neglect of the 2-year-old, the 4-year-old, and one of the 5-year-old children by the father, the mother to the youngest five children, and the paternal grandmother. The Initial Assessment found insufficient evidence to substantiate neglect of the 1-month-old, the 1-year-old, the other 5-year-old, and the 8-year-old by the father and the mother to the youngest five children. The agency determined the children were unsafe and initiated a Protective Plan. Subsequently the 1-month-old, 1-year-old, 2-year-old, 4-year-old, and one of the 5-year-olds were taken into Temporary Physical Custody and placed with a relative. The other 5-year-old and the 8-year-old were deemed safe with their mother. Petitions for Protection or Services were filed for the five children taken into Temporary Physical Custody, and the case remained open to provide ongoing case management services.
