**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On July 24, 2024, the agency received a report regarding a 10-month-old infant found unresponsive in his home and taken to the hospital. The infant was later pronounced deceased on July 26, 2024. Law enforcement was contacted and initiated a criminal investigation. The Coroner noted no signs of trauma to the infant. The official cause of the infant's death was undetermined, and the toxicology results were negative. No criminal charges have been filed in this case, and the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Coroner noted no signs of trauma to the infant. The official cause of the infant's death was undetermined, and the toxicology results were negative. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the infant by a non-relative caregiver. The agency deemed the infant's half-siblings safe, and they remained with their father. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.
