Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On December 11, 2024, the agency received a report regarding a 9-month-old infant brought to the hospital with head injuries. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were consistent with non-accidental head trauma. No criminal charges have been filed in this case, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. Medical professionals determined the injuries were consistent with non-accidental head trauma. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate neglect of the infant by the mother and father. The agency deemed the infant and the infant's 1-year-old sibling unsafe and initiated a Protective Plan. Subsequently, the infant and the infant's 1-year-old sibling were taken into Temporary Physical Custody and placed in a foster home. The infant and the infant's 1-year-old sibling were later placed with a relative. The agency determined the infant's 6-year-old sibling safe, and they remained with their mother. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.

At the time of the incident, the agency was assessing the December 9, 2024 Services Report. The agency had not yet contacted the family at the time of the incident.

On December 9, 2024, the agency screened in a Services Report. The infant was injured during the assessment period and an additional CPS Report was made to the agency regarding the infant's injuries on December 11, 2024. An assessment of the concerns documented in the initial Services Report was included in the assessment of the December 11, 2024 CPS Report, and the allegation of neglect was substantiated.

On February 8, 2021, the agency screened in a CPS Report alleging physical abuse to the infant's now 6-year-old sibling by the mother and father. An assessment was completed by the agency, and the allegations of physical abuse were

unsubstantiated. The case was closed upon completion of the Initial Assessment, and the family was referred to community services.
