**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On December 31, 2024, another agency received a report regarding a 6-year-old child and 5-year-old child involved in an egregious incident. Subsequently it was determined that the children resided in Monroe County and Monroe County Department of Human Services (the agency) responded. Law enforcement was contacted and initiated a criminal investigation. As a result of law enforcement's investigation, the father was criminally charged with Attempted 1st Degree Intentional Homicide, Aggravated Battery- Intend Great Bodily Harm, 1st Degree Reckless Injury, and 1st Degree Recklessly Endangering Safety. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect of the children by the father. The agency determined the children safe, and they remained with their mother. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.
