Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On January 2, 2025, the agency received a report regarding a 12-year-old child pronounced deceased on December 30, 2024. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the child's death was non-accidental in nature. As a result of law enforcement's investigation, the mother's former significant other was criminally charged with First Degree Intentional Homicide, Hiding a Corpse, and Possession of a Firearm by a Felon. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the child by the mother's former significant other. The agency determined the child's 17-year-old half sibling safe, and the half-sibling remained with the mother. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.
