Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On February 18, 2025, the agency received a report regarding a 5-year-old child brought to the hospital with serious injuries that were sustained on February 17, 2025. Subsequently, the child was pronounced deceased. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the child died as a result of a serious injury. As a result of law enforcement's investigation, an unrelated adult was criminally charged with Neglecting a Child-Consequence is Death-As Party to a Crime and Possession of a Firearm by a Felon. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the child by the child's adult relative. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.
