Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On April 1, 2025, the agency received a report regarding a 6-year-old child pronounced deceased in his home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the child died as a result of a serious injury. As a result of law enforcement's investigation, the child's mother was criminally charged with Neglect of a Child, Consequence is Death, and the child's uncle was criminally charged with Neglect of a Child, Consequence is Death and Second-Degree Reckless Homicide. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professions to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect of the child by the mother and the uncle. The agency deemed the child's half-siblings unsafe and initiated a Protective Plan. Subsequently, the child's half-siblings' father was assessed as protective, and the child's half-siblings remained with their father. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.
