### Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On April 14, 2025, the agency received a report regarding a 7-year-old child brought to the hospital on April 12, 2025. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined that the child had ingested a controlled substance. No criminal charges have been filed, and the case was closed.

### Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the child by the mother's significant other. The agency determined the child and the child's siblings safe, and they remained with their mother. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.
