### Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On May 3, 2025, the agency received a report regarding a 3-year-old child pronounced deceased in her home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the child died as a result of a serious injury. No criminal charges were filed, and the case was closed.

### Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect by the child's mother, the child's grandfather, and an unnamed maltreater. The child's siblings were deemed safe, and they remained with the mother. The family was referred to community services, and the agency closed the case upon completion of the initial assessment.
