**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On May 6, 2025, the agency received a report regarding an 8-month-old infant pronounced deceased. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma; the autopsy report is pending. No criminal charges have been filed, and the case was closed.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency using Alternative Response determined that services were not needed. The agency determined the infant's siblings safe, and they remained with the mother and father. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.

On May 23, 2023, the agency screened-out a CPS Report.

On March 9, 2017, the agency screened-in a CPS Report alleging neglect to the infant's now 8-year-old sibling by the mother. An assessment was completed by the agency, and the allegation of neglect was unsubstantiated. The case was closed upon completion of the Initial Assessment.

On February 11, 2015, the agency screened-in a CPS report for Alternative Response alleging neglect to the infant's now

10-year-old sibling by the mother and father. An assessment was completed by the agency, and it was determined services were needed. A Petition for Protection or Services was filed on February 19, 2015, and the case remained open to provide ongoing case management services.

The agency collaborated with law enforcement and medical professionals to complete the assessment.
