On May 16, 2025, the agency received a report regarding of an egregious incident involving a 14-year-old child and 3-year-old child that occurred on May 15, 2025. Law enforcement was contacted and initiated a criminal investigation. As a result of law enforcement's investigation, an unrelated individual was criminally charged with Attempted 1st Degree Intentional Homicide. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement to complete the assessment. The Initial Assessment completed by the agency using Alternative Response determined that services were not needed. The agency deemed the children unsafe and initiated a Protective Plan. Subsequently, the mother was assessed as protective, and the children remained with the mother. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.
