**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On May 15, 2025, the agency received a report regarding a 1-year-old infant found unresponsive in his home who was taken to the hospital and was subsequently pronounced deceased. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined that the infant died as a result of drowning. As a result of law enforcement's investigation, the infant's mother was criminally charged with Neglect of a Child Resulting in Death. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect to the infant by the infant's mother. The agency deemed the infant's half-sibling safe with a relative. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.

On October 27, 2021, the agency screened-out a CPS Report.

On July 8, 2016, the agency screened-in a CPS Report alleging neglect to the infant's now 8-year-old half-sibling by the

mother. An assessment was completed by the agency, and the allegation of neglect was unsubstantiated. A Petition for Protection or Services was filed on July 14, 2016, and the case remained open to provide ongoing case management services.
