Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On May 16, 2025, the agency received a report regarding an 11-year-old child pronounced deceased in his home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the child died as a result of a serious injury. As a result of law enforcement's investigation, an individual was referred for charges. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate physical abuse of the child by an unnamed individual. The agency found insufficient evidence to substantiate neglect of the child by the child's mother and grandmother. The child's siblings were deemed safe, and they remained with the mother. The family's case remained open for ongoing case management services.

On November 14, 2022, the agency screened-in a CPS Report alleging neglect of the child's now 12-year-old, 15-year-old, 16-year-old, and adult siblings by the child's mother, and sexual abuse to the child's now 12-year-old, 15-year-old, and adult siblings by a relative. An assessment was completed by the agency, and the allegations of neglect and sexual abuse were unsubstantiated. The case was closed upon completion of the Initial Assessment.

On May 5, 2020, the agency screened-in a CPS Report for Alternative Response alleging physical abuse to the child's now 15-year-old and adult siblings by relatives and neglect to the child's now adult sibling by the mother. An assessment was completed by the agency, and it was determined services were not needed. The case was closed upon completion of the Initial Assessment.

On May 5, 2020, the agency screened-in a CPS Report for Alternative Response alleging physical abuse to the child's now 15-year-old and adult siblings by relatives and neglect to the child's now adult sibling by the mother. An assessment was completed by the agency, and it was determined services were not needed. The case was closed upon completion of the Initial Assessment.

On May 10, 2018, the agency screened-in a CPS Report alleging neglect to the child and the child's now 12-year-old, 16-year-old, and adult siblings by the mother. An assessment was completed by the agency, and the allegations of neglect were unsubstantiated. The case was closed upon completion of the Initial Assessment.

On May 6, 2018, the agency screened-out a CPS Report.

On March 26, 2018, the agency screened-out a CPS Report.

On November 20, 2017, the agency screened-in a CPS Report alleging neglect to the child and the child's now 12-year-old, 15-year-old, 16-year-old, and adult siblings by the mother. An assessment was completed by the agency, and the allegations of neglect were unsubstantiated. The case was closed upon completion of the Initial Assessment.

On November 15, 2016, the agency screened-in a CPS Report alleging neglect and physical abuse to the child and the child's now 12-year-old, 15-year-old, 16-year-old, and adult siblings by the mother. An assessment was completed by the agency, and the allegations of neglect and physical abuse were unsubstantiated. The case was closed upon completion of the Initial Assessment.

On August 29, 2014, the agency screened-in a CPS Report alleging neglect and physical abuse to the child and the child's now 12-year-old, 15-year-old, 16-year-old, and adult siblings by the mother and grandmother. An assessment was completed by the agency, and the allegations of neglect and physical abuse were unsubstantiated. The case was closed upon completion of the Initial Assessment.

On June 6, 2014, the agency screened-in a CPS Report alleging neglect and physical abuse to the child and the child's now 12-year-old, 15-year-old, 16-year-old, and adult siblings by the mother. An assessment was completed by the agency, and the allegations of neglect and physical abuse were unsubstantiated. The case was closed upon completion of the Initial Assessment.

On March 3, 2014, the agency screened-in a CPS Report alleging neglect to the child and the child's now 12-year-old, 15-year-old, 16-year-old, and adult siblings by the mother. An assessment was completed by the agency, and the allegations

of neglect were unsubstantiated. The case was closed upon completion of the Initial Assessment.

On August 30, 2013, the agency screened-in a CPS Report alleging neglect and physical abuse to the child and the child's now 12-year-old, 15-year-old, 16-year-old, and adult siblings by the mother. An assessment was completed by the agency, and the allegations of neglect and physical abuse were unsubstantiated. The case was closed upon completion of the Initial Assessment.

On September 8, 2008, the agency screened-out a CPS report.

On May 23, 2007, the agency screened-in a CPS report alleging neglect to the child's now adult siblings by the mother. An assessment was completed by the agency, and the allegations of neglect were unsubstantiated. The case was closed upon completion of the Initial Assessment.

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate physical abuse of the child by an unnamed individual. The agency found insufficient evidence to substantiate neglect of the child by the child's mother and grandmother. The child's siblings were deemed safe, and they remained with the mother. The family was referred to community services, and the agency closed the case upon completion of the initial assessment.
