Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On June 22, 2025, the agency received a report regarding a 2-year-old child brought to the hospital with head injuries. The child was later pronounced deceased on June 23, 2025. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the death was non-accidental in nature. As a result of law enforcement's investigation, the mother's significant other was criminally charged with First Degree Reckless Homicide. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner's Office determined the death was non-accidental in nature. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse and neglect of the child by the mother's significant other. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.

At the time of the incident, the agency was assessing the June 5, 2025, CPS Report. The last contact by the agency was a phone call with the mother on June 12, 2025.

On June 5, 2025, the agency screened-in a CPS report for Alternative Response alleging neglect to the child by the mother.
