On July 9, 2025, the agency received a report regarding a 1-year-old infant brought to the hospital with multiple injuries. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were non-accidental in nature. No criminal charges have been filed in this case, and the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the infant by the mother's ex-significant other. The agency deemed the infant and the infant's 5-year-old half-sibling unsafe and initiated a Protective Plan that was later transitioned to an in-home safety plan with the mother. The family's case remained open for voluntary case management services.
