Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On July 10, 2025, the agency received a report regarding a 4-year-old child pronounced deceased in his home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the child died as a result of a serious injury. As a result of law enforcement's investigation, the child's father was criminally charged with 1st Degree Intentional Homicide and the child's mother was criminally charged with Neglecting a Child, Consequence is Death. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the child by the father and neglect of the child by the mother. The child's 17-year-old half-sibling was deemed safe in the care of a relative. The child's 12-year-old half-sibling was deemed unsafe, taken into Temporary Physical Custody, and placed with a relative. A Petition for Protection or Services was filed, and the case remained open to provide ongoing case management services.
