**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On July 19, 2025, the agency received a report regarding a 7-month-old infant who was in out-of-home placement with a relative and who was pronounced deceased in the home of her mother and father. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner’s Office noted no signs of trauma to the infant; the autopsy report is pending. No criminal charges have been filed in this case, and the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect of the infant by the mother and father. The agency deemed the infant’s half-siblings safe in their relative foster homes. The case remained open for ongoing case management services.

At the time of the incident, the infant was residing with a relative through court-ordered kinship care. The infant was originally placed in out-of-home care on March 25, 2025, after being taken into Temporary Physical Custody due to allegations of neglect by the mother.

**Description of all other persons residing in the OHC placement home:**

At the time of the incident, the infant was residing with a relative and her 3-year-old and 2-year-old half-siblings. The infant’s 7-year-old and 5-year-old half-siblings were residing with another relative. The infant’s half-siblings were placed in out-of-home care on March 25, 2025, after being taken into Temporary Physical Custody due to allegations of neglect by the mother.

The relative was an unlicensed kinship care provider. The relative had no history constituting a substantial failure to protect and promote the welfare of the child.
